Introduction

In Ukraine, in the years of independence, the structure and functioning of public authorities at all levels have been changing in accordance with the Constitution of Ukraine. The development of all forms of ownership and civil society requires the transformation of the bureaucracy into an effective internal system of governance that will serve the protection of the rights and legitimate the interests of citizens. And this, in turn, predetermines the objective necessity for the further development and strengthening of the activities of public servants under new conditions.

The determining criterion for such changes is the introduction of the European standards of service of citizens and professional servicing of political leadership in the activity of the servants of Ukraine. Decisions on such implementation are provided by the Concept of Adaptation of the Civil Service Institution to the standards of the European Union, approved by the Decree of the President of Ukraine dated March 5, 2004, as well as the Concept for the Development of the Civil Service Legislation in Ukraine, approved by the Decree of the President of Ukraine dated February 20, 2006.

A deep understanding of the problems that arise in the process of forming the modern doctrine of public service, the concept of public services, as well as the corresponding institution, will contribute to a more rational approach to the formation of personnel policy in accordance with the new tasks and functions of the state, will help overcome the estrangement of society from public authority, raise the professionalism and competence of public service providers. The academic discipline "Theory and Methodology of Public Management and Public Administration" is compiled according to the educational and scientific program of PhD training in speciality 281 "Public Management and Administration".

Public administration is a sphere of activity that deserves to be learnt due to its importance for the general education of a student. The study of the academic discipline "Theory and Methodology of Public Management and Public Administration" will promote an awareness of theoretical and methodological principles of public administration, in-depth understanding of governance, substantiation of the main features of the state and clarification of the peculiarities of the public administration at the state, regional and local levels.

2. The purpose and tasks of the academic discipline

The purpose of teaching the academic discipline "Theory and Methodology of Public Management and Public Administration" is the mastering of theoretical knowledge and the formation of professional competences in understanding the theoretical and methodological principles of public administration, in-depth understanding of governance, substantiation of the main features of a state, and clarification of the peculiarities of public administration at the state, regional and local levels.

To achieve the goal, the following main tasks are set:

mastering the foundations of methodological research in the field of public administration and the theoretical foundations of democratic governance;

mastering modern approaches to determining the effectiveness and efficiency of public administration, models of theories in public administration and skills in their identification in practical activities;

acquiring knowledge about the culture and ethics in public administration to resolve conflicts in the development and use of antistress measures;

mastering modern mechanisms of management of social development in substantiating the trends in the development of socio-political processes;

assimilation of innovative development priorities of a country; development of on-line improvement of processes in the field of public administration.

Theory and Methodology of Public Management and Public Administration is a discipline that studies the tools for effective management of socio-political processes in the country.

The object of the discipline is the social and political processes that take place in public administration.

The subject is the regularities, principles, functions, methods, means, models and processes in public administration, and the development of practical recommendations for enhancing the influence of public administration in Ukraine.

In the process of training, seekers for the educational-scientific degree "Doctor of Philosophy" get the necessary knowledge during lectures and while performing practical tasks. The most difficult issues are submitted for discussion at the seminar sessions. Independent work is also very important in the process of learning and consolidating the knowledge. All the classes are designed in accordance with the credit transfer system of the educational process.

As a result of studying the discipline, the seekers for the educationalscientific degree "Doctor of Philosophy" should

know:

the methodological foundations of public administration;

public administration tools;

public administration models;

the conflict resolution technology in public administration and stress management techniques;

the foundations of culture and ethics in public institutions;

the modern mechanisms for managing social development;

the evolution of the theory of a state and society;

the content of socio-political processes and understanding of possible trends of development;

innovative technologies of public administration;

theory and practice of using public administration abroad and in Ukraine;

be able to:

apply modern approaches in the field of public administration and civil service using modern tools, techniques and technologies;

develop systems of public reporting in institutions of public administration; determine the effectiveness and efficiency of democratic governance; analyze and, if necessary, adapt foreign experience of applying models in the field of public administration;

use conflict resolution tools and antistress tools in public administration; identify modern mechanisms of social development management;

carry out diagnostic analysis of socio-political processes and determine the priority development trends;

identify the trends of innovation development in Ukraine and develop measures to enhance innovative activities in the field of public administration.

In the process of teaching the discipline, the main attention is paid to the acquisition of professional competences by the seekers for the educationalscientific degree "Doctor of Philosophy" which are given in Table 2.1.

The sphere of realization of the acquired knowledge, skills and competences in the future profession is the public sector: state and local authorities and administrations, regional branches of central executive bodies, nonprofit organizations and public organizations.

The professional activity includes the application of public administration tools at the state, regional and local levels, introduction of principles of democratic public administration in the work of the authorities and public organizations.

A specialist is trained to perform the work of a senior official of trade unions and other organizations, managerial staff of the apparatus of central and local governmental bodies, local authorities, heads of financial, accounting, economic, legal and administrative departments, heads of advertising and public relations departments, project and program managers, civil service professionals, managers (supervisors) in the field of research and development.

4. The structure of the academic discipline

From the beginning of the study of the discipline, each seeker must be acquainted with both the syllabus and the forms of training, as well as with the structure, content and volume of each of its educational modules, as well as with all types of control and assessment methods of the developed professional competences.

The study of the discipline is carried out through a consistent and thorough learning of the educational modules. The module is a separate, relatively independent unit of the academic discipline which logically combines several educational elements of the discipline in terms of content and interconnections. The thematic plan of the discipline consists of two content modules (Table 4.1).

5. The themes and plans of seminars

A seminar is a form of training, when the lecturer organizes a discussion on the predefined themes, to which students prepare theses of speeches and reports, as well as problem questions, the answer to which should be found during the discussion. At each seminar, the lecturer assesses the reports and presentations prepared by the seekers on the given issues

(Table 5.1), their performance, participation in the discussion, the ability to formulate and uphold their views, etc. The final points for each seminar session are displayed in the corresponding register. The points received by a student for the seminar classes are taken into account in the process of accumulation of the final points on this discipline.

During the seminar, the time is clearly set for each type of work. The active participation of students in the seminar is expected to be properly evaluated.

6. The themes of practical classes

A practical lesson is a form of training, where the teacher organizes a detailed consideration of certain theoretical issues of the discipline and forms the skills in the practical application of theory through individual execution of the formulated tasks. Conducting such classes is based on pre-prepared methodical materials – tests to identify the degree of mastering of the necessary theoretical issues, a set of tasks of different levels of complexity to be solved in class. It includes prelimirary control of knowledge, skills and abilities of seekers, raising a general problem by the teacher and discussing it with the participation of the seekers, solving problems through discussions, doing test tasks, review and evaluation of the tasks (Table 6.1).

6.1. Examples of typical practical tasks according to the themes

Content module 1

The theoretical and historical principles of public administration

Theme 5. Culture and ethics of public administration

Level 1. You are the chief specialist of the information and analytical department in the regional state administration.

You need to offer top management tools for public administration that will ensure the balanced development of Kharkiv region. The answer is to be reasoned.

Level 2. It is quite often when a public servant has a private interest, that is, the benefits to him or his family, close relatives, friends or individuals and organizations with whom he has or has had a common business or political interests, which, in turn, affects or may affect the impartial and objective performance of official duties, thereby causing a conflict situation in the workplace.

How to resist such a conflict of interests? How are the restrictions on public servants imposed at the legislative level?

Level 3. The modern stage of historical development is called the period of complex political, social and economic processes. Changes that occur unexpectedly affect management not only in the field of environment, technology and economics, but also in the field of social and political development. In such circumstances, the competent and timely account of these changes by the top echelon of managers and taking the appropriate measures becomes of a paramount importance.

Which of the following measures, in your opinion, is advisable for a manager to respond to the unexpected changes in the situation? The answer is to be reasoned.

A. First of all, the nature of the changes should be evaluated and then aligned with the goals and activities of the organization itself, as well as the methods of managing it.

B. In the event of changes, hasty, inappropriate decisions are always taken, and the futile, unnecessary efforts are made. That is why the organization works unevenly. Therefore, it is urgent to identify all the negative situations, to eliminate them and try to maintain the necessary stability in the organization.

C. Changes that occur in the surrounding environment affect the skills needed by the organization's employees. Therefore, efforts should be taken to ensure that they can adapt to any changes.

Content module 2

Modern mechanisms of social development management

Theme 9. Socio-political processes: the content and development trends

Level 1. The priority task of public administration is to raise the ability of the state apparatus to provide the appropriate quality management both at the level of political governance and at the level of professional administration, to increase its efficiency and effectiveness not only from the point of view of managers but citizens as well. The characteristics of such a managerial process are now expressed through the concept of good (democratic) governance.

What is good (democratic) governance? Describe each of its components.

Level 2. You work as the chief specialist of the information and analytical department of the regional state administration. You need to offer to the top management the tools of public administration that will ensure the balanced development of Kharkiv region. The answer is to be reasoned.

Level 3. You work as a specialist in the Kharkiv Regional Committee for Economic Reforms. At the regular meeting of the Regional Economic Development Working Group, the need to develop a program of territorial development of Kharkiv region and its balanced functioning for 2017 – 2018 is to be discussed. You have to propose a model of interaction between the subjects of management of strategic territorial development. Justify the answer.

7. Independent work

Independent work of students (IWS) is a form of organization of the educational process, in which the planned tasks are performed by a student independently under the teacher's methodological guidance.

The purpose of the IWS is to learn in full the curriculum and to form the general and professional competences which will play a significant role in the future formation of the PhD. The time for independent work of full-time students is determined by the curriculum and makes 73.3 % (88 hours) of the total amount of the time allocated for the academic discipline (120 hours).

In the course of independent work, students should become active participants in the learning process, learn to develop a conscious attitude to the acquisition of theoretical and practical knowledge, to navigate in the information space, to carry individual responsibility for the quality of their educational and scientific activities.

Independent work of students within the discipline "Theory and Methodology of Public Management and Public Administration" includes:

studying the recommended literature on the themes and searching for additional literature;

studying the lecture material;

making notes of separate issues that have not been considered at the lectures:

execution of situational and creative tasks on the issues of the academic discipline;

writing papers and short reports for seminars;

preparation for running tests and colloquia.

The tasks of independent work which are envisaged by the syllabus and by the curriculum for the acquisition of theoretical knowledge and practical skills are given in Table 7.1.

8. Individual advisory work

9. Methods of training

In the process of teaching the academic discipline, in order to stimulate the educational and cognitive activity of students, the application of both active and interactive learning technologies is provided including the following: problem-oriented lectures, minilectures, work in small groups, seminardiscussions, brainstorming, the case study method, presentations, introductory (initial) games, the method of design work, computer simulations, the Delphi method, the scenario method, banks of visual support (Tables 9.1 and 9.2).

The main differences between active and interactive methods of teaching and the traditional ones are determined not only by the methodology and teaching techniques, but also by high efficiency of the learning process which is manifested in: high motivation of students; consolidation of theoretical knowledge in practice; increased self-awareness of students; formation of the ability to make independent decisions; formation of the ability to make collective decisions; formation of the capacity for social integration; acquisition of conflict resolution skills; development of the ability to find compromise.

A problem-oriented lecture is one of the most important elements of problem-based training of students. They provide, along with the consideration of the main lecture material, setting and consideration of a range of disputable issues that have not been sufficiently developed in science and studying their relevance to theory and practice. Problem-oriented lectures are distinguished by an in-depth argumentation of the material being taught. They contribute to the formation of independent creative thinking of students, training their cognitive skills. Students become participants in scientific research and problem solving.

Minilectures provide presentation of the training material in a short period of time and are characterized by a significant capacity, complexity of logical constructions, images, evidence and generalizations. As a rule, they are conducted as a part of study. Minilectures differ from full-length lectures by a significantly shorter duration. Typically, minilectures last no more than 10 – 15 minutes and are used to briefly convey new information to all listeners. Minilectures are often used as a part of a holistic theme, which is desirable to be taught as a full-length lecture so as not to tire the audience. Then the information is provided in turn by several separate segments, alternating with other forms and methods of teaching.

Seminar-discussions imply the exchange of the participants' opinions and views on the theme. They develop thinking, help shape opinions and beliefs, develop the ability to formulate and express thoughts.

Work in small groups makes it possible to structure practical classes in the form and content, creates opportunities for each participant to take part in the work on the theme of classes, provides opportunities for the formation of personal qualities and experience of social communication.

Brainstorming is a method of solving urgent tasks, the essence of which is to express as many ideas as possible within a very limited period of time, discuss and select them.

Presentation is making a speech to the audience, used to present certain achievements, results of the team work, reports on the implementation of individual tasks or projects. Presentations can be either individual, such as the performance of one competitor, or collective, that is, the performances of two or more students.

The Delphi method is used to reach consensus in expert assessments. It provides the opportunity to express the views to a group of experts who work individually in different places. When choosing a managerial decision for this method, the academic group is divided, for example, into five small subgroups. The four groups are workers, they develop and make managerial decisions, and the fifth group is an expert one. Analysis and management options for effective management of working groups are averaged by this group. The expert group can be divided into specialities.

The method of scripts develops probable patterns of behaviour and specific phenomena in the future.

10. Methods of control

The system of evaluation of the developed competences (Table 2.1) takes into account the types of work that, according to the curriculum, include lectures, seminars, practical classes, and independent work. The evaluation of the developed competences of students is carried out using a 100-point accumulation system. In accordance with the Provisional Regulations "On the Procedure for Assessment of Students' Academic Performance on the Accumulation Point-Rating System" of S. Kuznets KhNUE, the methods of control include:

current control, which is carried out during the semester at the lectures, practical classes, seminars and is estimated by the sum of the points scored (the maximum number is 100 points; the minimum number that allows a student to receive a score is 60 points);

modular control, which is conducted taking into account the current control over the corresponding content module and is aimed at an integrated assessment of the results of a student's training after studying the material from the logically completed part of the academic discipline – the content module;

final/semester control conducted in the form of a differentiated test, according to the schedule of the educational process.

Current control on this discipline is carried out in the following forms:

active work at lectures;

active participation in the performance of practical tasks;

active participation in the discussion and presentation of material at seminars;

writing an essay on the given theme;

ongoing testing;

conducting a written test;

express survey;

writing a dictation on the lecture material.

Modular control on this discipline is carried out in the form of a colloquium. A **colloquium** is a form of examination and evaluation of students' knowledge in higher education institutions. It is conducted as an intermediate miniexam on the lecturer's initiative.

The final/semester control is carried out in the form of a differentiated test based on the accumulation point-rating system.

The procedure for conducting current assessment of students' knowledge. Assessment of students' knowledge during seminars and practical classes and the performance of individual tasks is carried out using a 100-point accumulation system according to the following criteria:

understanding, the degree of assimilation of the theory and methodology of the problems under consideration;

the degree of assimilation of the actual material of the academic discipline;

familiarization with the recommended literature, as well as the latest publications on the issues under consideration;

the ability to combine theory with practice when considering production situations, solving problems, doing calculations in the process of performing individual tasks and tasks submitted for consideration in the classroom;

logic, structure, style of presentation of the material in written papers and speeches to the audience, the ability to substantiate their points of view, to generalize information and draw conclusions;

the arithmetic correctness of the performance of an individual and complex calculation task.

The maximum possible score for a specific task is given on the condition that the written or oral assignment completed by the student meets all the specified criteria. Absence of one or another component reduces the number of points. When evaluating individual tasks, attention is also paid to the quality, independence and timeliness of the tasks performed by the student, in accordance with the schedule of the educational process. If any of the requirements are not met, the points are reduced.

Current control is carried out 2 times per semester and includes a test and practical tasks of different levels of complexity in accordance with the content modules.

The criteria for evaluating extracurricular independent work of students. The general criteria for assessing the extracurricular independent work of students are: the depth and strength of knowledge, the level of thinking, the ability to systematize knowledge of specific themes, the ability to draw informed conclusions, the mastery of the categories and concepts, skills and techniques for performing practical tasks, the ability to find, systematize and process the necessary information, self-realization during practical classes and seminars.

The criteria for evaluation of essays are:

the ability to conduct a critical and independent assessment of certain issues;

the ability to explain alternative views and express their own points of view on a certain problematic issue;

application of analytical approaches;

quality and clarity of reasoning;

logic, structuring and substantiation of conclusions on a specific problem; independence of work;

literacy of presentation of the material;

the use of the methods of comparison, generalization of concepts and phenomena;

the format of the work.

The final control is carried out in the form of a differentiated test on the accumulative point-rating system within the terms provided by the schedule of the educational process.

A student does not receive a score if the number of points obtained for the results of the progress during the current and modular control (according to the content module) during the semester has not reached 60 points.

Practical task 1. Draw a diagram of the relationship between public administration and state governance using the following elements: society, state administration, three branches of power, state policy, public policy, local government, good governance, electronic governance.

Practical task 2. One of the characteristic features of a foreign model of local self-government is the lack of in-field representatives of central government which cares for local elected bodies. Name this model of the local self-government, identify its other specific features and list the countries where it is used.

The maximum number of points for the assessment of the tasks of the colloquium is 10. Each colloquium task is evaluated separately.

Test tasks contain 20 questions. Each correct answer to the question is scored at 0.25 points.

The algorithm for solving a practical problem involves separate steps which differ in complexity, work content and significance for solving the problem. Therefore, separate tasks and stages of solution are evaluated separately from each other as follows:

Assessment of the correctness of practical task 1 is equal to 3 points and includes:

1 point – for the correct characterization of the public administration model:

1 point – for providing a complete list and characteristics of public administration principles which are basic for the implementation of public administration;

1 point – for availability and depth of conclusions.

The score for the correctness of practical task 2 equals 2 points, and includes:

- 1 point for the correct characterization of the local self-government model;
- 1 point for a substantiated conclusion regarding the use of the definite model of public administration in Ukraine.
