Abstract of the educational discipline

The deepening of international cooperation allows the use of world experience in the implementation of regional economic activities. This causes the growing role of international economic relations and their study in the context of the domestic economy.

The study of the discipline "World Economy and International Economic Relations" is aimed at mastering the trends of international economic relations and the development of the world economy; formation of practical skills in the analysis of events in modern international economic relations and further use of acquired skills.

he course is aimed at forming students' general foundations for the analysis of patterns and features of international economic relations, obtaining the necessary knowledge on the activities of leading countries in foreign economic activity, the peculiarities of international relations.

The discipline "World Economy and International Economic Relations" is a basic discipline and is studied in accordance with the curriculum for training specialists of the educational level "Bachelor" specialty 292 "International Economic Relations" of the educational program "International Business" of all forms of education.

The purpose of teaching the discipline is to form a system of knowledge, skills and practical abilities on the theoretical foundations and methodological and practical tools for the development and current state of international economic relations.

Syllabus of the educational discipline

Content module 1. Economics of world economic relations: patterns of functioning and development

Theme 1. Characteristic features and trends of the world economy.

Subject of study of the course "World Economy and International Economic Relations", its place among other economic disciplines; structure and logic of teaching. Significance in the training of management professionals. Purpose, tasks and new approaches to the study of the course, its information and methodological support.

World economy: essence, elements and subjects, formation, factors of development. International economic cooperation. Qualitative and quantitative aspects of the world economy. The

main trends in the formation of the world economy, levels and cycles of its development.

Theme 2. International division of labor.

The essence and factors of the international division of labor. Types of international division of labor. Forms and directions of development of international specialization and cooperation of production.

The main trends of the international division of labor. Problems of Ukraine's participation in the international division of labor.

Theme 3. Sectoral aspects of the development of the modern world economy. Typology of countries and the role of their individual groups in the world economy. Countries and regions in the modern world economy.

Uneven socio-economic development of the world and their typology. The regional principle of grouping and the main regional groups of the world.

Socio-economic principle of systematization of the world. Organization for Economic Cooperation and Development (OECD) countries. Three centers of economic development. Small privileged nations. Countries of resettlement capitalism. Middle-income countries.

Developing countries: concepts, general features and place in the world economy. Socio-economic structure. Countries with economies in transition, the formation of their economic groups and the problems of integration into the world market economy. Centralized planning countries.

The place of individual groups of countries in the world economy. Leading importance of industrialized countries.

The problem of eliminating economic backwardness and neocolonial dependence of developing countries, features of their international economic relations. Implementation of the New International Economic Order. Problems of integration into the world economy of countries with economies in transition, changes in the development of their international economic relations.

Theme 4. International corporations in the world economy. Globalization transformations as a factor of integration processes in the world economy. International economic cooperation.

TNCs - the main actors of international production and investment activities, their significance and evolution, modern strategy. Types of monopoly associations. The role of internal cooperation exchange. Contradictions between TNCs and the national-state form of political organization of society. Regulation of TNCs.

Monopolization of world trade. Activities of TNCs and competition in the world market. Types of commodity markets by degree of monopolization. Closed and open sectors of the world market, their features.

Joint ventures (JVs). Prerequisites and features of joint venture development. Organizational, legal and economic forms of creation and operation of the joint venture. The scale, level and dynamics of JV development. Free economic zones.

International economic integration - a pattern of development of the world economy and international economic relations. The essence, goals and significance of international economic integration, the main features. Prerequisites and factors of development of MEI of international economic integration as a qualitatively new level of international economic relations. The main participants and organizers of the process of international economic integration, its modern features. Forms of international economic integration. Stages of formation of international economic integration groups.

World integration processes and Ukraine. Regional nature of international economic integration as its feature. Regional integration associations of industrialized countries. Objective preconditions, political and economic goals, the main stages of development of Western European economic integration. Unity of the economic system of the EU. Features of agricultural development. Creation of the Western European model of unified industrial and scientific and technical development. Unified scientific and technical policy. European monetary system. Institutional structure: and political and legal mechanisms of the EU. EU policy towards third countries and their groups. Problems of further EU enlargement. Ukraine and the EU. North American economic integration. Formation of the North American Free Trade Area (NAFTA). The United States in global integration processes. US global

policy on the processes of European economic integration. Features of economic relations with the countries of the Asia-Pacific region. Integration processes in the economies of developing countries. The role of MEI in the implementation of NMEP. Features of economic integration of Latin America. Development of regional and subregional integration groups. Latin American Association for Integration (LAAI). Andean Group and the Amazon Pact. Central American Common Market (CACR). Caribbean Cooperation (CARICOM). Latin American Economic System. Common Market of the Southern Cone (MERCOSUR). Problems and prospects of creating a system of collective economic action in Latin America. Problems of development of regional economic cooperation in Africa. The main economic groups of African countries. Economic Cooperation of West African States (ECOWAS). Customs and Economic Union of Central Africa, its transformation into the Economic and Monetary Union of Central Africa. Common market of the Maghreb countries. Common Market of East and South Africa (COMESA). South African Development Cooperation. Problems of formation of African economic cooperation. Features of the development of economic integration in Asian countries. Association of Southeast Asian Nations (ASEAN). South Asian Association for Regional Cooperation. Asia-Pacific Economic Cooperation (APEC). Gulf Arab Cooperation Council. Problems of development of economic integration in Eastern European countries in the new conditions of transition to a market economy, the creation of a new model of economic integration. Eastern European Cooperation and Free Trade. Ukraine and integration groups of countries.

Content module 2. Features of the implementation of forms of international economic relations at the mega, macro, meso and micro levels

Theme 5. International economic system and international economic relations. The environment of international economic relations. Features of the functioning of the subjects of international economic relations.

International economic relations as an economic category. Significance of international economic relations, their significance, objective basis and preconditions for development. Levels of development of international economic relations: functional, economic, territorial, by subjects of activity. Features of the development of international economic relations at the present stage. The role of international economic relations in the process of Ukraine's integration into the system of world economic relations.

The concept of the environment of international economic relations, its structure and features. Natural and geographical environment, its main components of influence on the development of international economic relations. Economic environment of formation of international economic relations, the state of market relations of countries and features of their relations. Economic regulators of international economic relations. Political and legal environment. Features of the interaction of politics and economics in international economic relations. Political interests of countries and regions. Political stability and political risks. International terrorism as a factor in shaping the political environment. Legal regulators of international economic relations. Socio-cultural environment and its importance in the development of international economic relations. Infrastructure of modern IEM. The role of transport and information and communication systems in the development of international economic relations.

Theme 6. International trade relations.

International trade as a defining form of international economic relations. The main factors of growth of international trade. Features of international trade. Standardization of goods on the world market. International product nomenclatures. Barcodes.

Regional structure (geographical distribution) of international trade. The structure of world trade by socio-economic groups of countries. The main causes and consequences of increasing mutual trade of industrialized countries. The role of developing countries in international trade. The place of the newly industrialized countries in world trade. Countries with economies in transition in international trade. Problems of foreign trade restructuring of the newly independent states. Conjuncture of commodity markets - the essence, factors of formation and development, the system of indicators of study and the main forms of manifestation.

Types and forms of international trade. Counter trade. International bidding (tenders).

International fairs and exhibitions. International auctions. Features of exchange trade, its evolution, organization and functions. Exchange goods. The largest international commodity exchanges, their impact on international trade. Types of exchange transactions. Consignment trade.

Features of the development of foreign trade policy of states. Protectionism and trade liberalization. Means of foreign trade policy. Manifestations of discrimination in international trade. Regional trade cooperation. Regulation of international trade relations. Activities of international trade organizations. GATT (General Agreement on Tariffs and Trade) and UNCTAD (United Nations Conference on Trade and Development). Transformation of the GATT into the World Trade Organization (WTO). Reorganization of COCOM (Export Control Coordination Council). The value of trade agreements and contracts in modern conditions. Activities of the International Chamber of Commerce. Prerequisites and features of Ukraine's participation in MT.

The importance of the world market of services, the prerequisites for its formation. Specific features of international trade in services, its dynamics, structure and geographical areas. Status and prospects of international trade in licenses and know-how. Types of license agreements. Modern conditions and factors of international technology exchange, forms of their transfer. Significance and volume of international trade in licenses. Features of preparation, execution and implementation of license agreements, the main countries-exporters of licenses. In-house licensed trade. International leasing, its types. Leasing by lease term. Features of renting. The main countries-exporters of leasing services. The value of international leasing. International engineering and consulting services. Tourist services on the world market. International tourist flows. Factors in the development of international tourism. Insurance services. Franchising in the system of international services.

Pricing in the world market. Price as an important indicator of commodity markets. International value and world price, its features. Pricing factors. Multiplicity of prices on the world market. World price levels. Information system of world commodity market prices.

Theme 7. International monetary, financial and credit relations.

National, international and world monetary systems, their essence and elements. The concept of currency and its types. Currency convertibility. Exchange rate, its types. Currency parity. Cross-course. Basic currency transactions. Currency quotes. The evolution of the world monetary system. The transition from the gold standard to the free course. Paris, Genoa, Bretton Woods and Jamaican currency systems. European monetary system. Monetary and financial system of the EU.

The essence of monetary and financial relations and the mechanism of international settlements. Balance of payments and settlement, their structure. Balance of international debt, its types. Instability of international settlements and the main problems of balance of payments of the world. The essence, methods and conditions of international settlements. The role of banks and their correspondent accounts in the organization and conduct of international payments. Risks in foreign economic activity, ways to eliminate them. Features of use in the international sphere of the basic forms of calculations. Non-documentary forms of payment: advance payment, bank transfer, payment after shipment, payment on an open account, payments by checks, plastic cards and promissory notes. Documentary forms of settlements: international settlements by letter of credit, international settlements by collection.

Theme 8. International mobility of human resources. International capital movements and technology transfer.

The concept of international labor migration, its economic nature, drivers and stages of development. Scales, forms and main trends in the development of modern migration processes. Types of international migration. The international market of highly qualified specialists ("golden collars") and the problem of "brain drain". The role of STR in the development of labor migration, scientific and engineering personnel. Socio-economic consequences of international labor migration. International labor migration and countries' balance of payments. General patterns of creation of the world labor market, the main regions and centers of its international attraction and export. International monopolies and the labor market. Forms and means of exploitation of immigrant workers. The impact of international economic integration on the internationalization of the labor market. State and international regulation of labor migration. The International Labor Organization and its role in addressing unemployment and protecting workers' rights. Programs to stimulate the elasticity of the

labor market and employment. Labor market flexibility. Problems of labor migration and labor market in Ukraine.

General preconditions for the development of international investment and production activities. International capital movements. "Investment climate". Types of foreign investment, their scale. Changes in the share of major economic centers in the export of capital. The main flows of international capital exchange. Features of capital movement regulation, the influence of TNCs on its movement. Capital outflow as a factor in the intensification of international investment and production activities. Foreign investment in the economy of Ukraine.

Prerequisites for international scientific and technical cooperation. Scientific and technical cooperation as a form of international economic relations. International movement of technologies and the mechanism of its transfer. Joint research. International research and development (R&D). Exchange of scientific and technical achievements and experience. Mutual consultations on the main issues of NTS. Development of scientific and technical forecasts. Cooperation in the field of scientific and technical information, invention and patent business. Collaborative research on environmental protection, medicine, space exploration and the oceans. Commercial content of scientific and technical relations. Development of trade in licenses and know-how. Intellectual property protection. Internationalization of NTS. International scientific and technical programs. Prospects for the inclusion of scientific and technical potential of Ukraine in international scientific and technical relations.

The list of practical classes, as well as questions and tasks for independent work is given in the table "Rating-plan of the discipline"

Teaching and learning methods

In the process of teaching the discipline "World Economy and International Economic Relations" methods are used that are aimed at activating and stimulating the educational and cognitive activities of higher education. During the lectures problem lectures, presentations, discussions on topical issues are used. During the practical classes the method of projects, case studies, work in small groups, presentations, brainstorming, individual work are used.

Mastering the first topic, students study case studies on trends in the world economy and present the results of work in the classroom. In a practical lesson on the second topic, students study the features of the international division of labor in the world on the basis of materials of international organizations and the results of international rankings, and finally present the results of the study. In a practical lesson on the third topic, students in small groups analyze the indicators of world trade around the world, developing recommendations for expanding areas of international economic relations and improving the situation on the world market. In a practical lesson on the fourth topic, students develop information documents on the activities of international organizations and determine their impact on the work of international companies. In the practical lesson on topic 5, students work on cases and solve situational problems to assess the international environment, followed by a discussion after processing. In a practical lesson on topic 6, students solve situations to assess the effectiveness of international trade in the markets of goods and services, as well as participate in the business game "International Commodity Exchange". In a practical lesson on 7 topics, students take part in a business game on international settlements, as well as solve situations related to currency, credit international settlements. In a practical lesson on topic 8 students, working in small groups, work on cases on international labor migration and international technology transfer.

Performing modular tests, students solve problems related to the development of the world economy and international economic relations, as well as perform test tasks on the topics of the relevant modular blocks.

During the lectures, methods of discussion on problematic issues, work in pairs, a presentation by a teacher, etc. are used. After the lecture, students must take an online test or participate in a chat discussion of the problem on the PNS during the week before the next lecture.

The procedure for evaluating learning outcomes

The system of assessment of formed competencies in students takes into account the types of classes, which in accordance with the curriculum of the discipline include lectures and practical classes, as well as independent work. Assessment of the formed competencies of higher education seekers is carried out according to the accumulative 100-point system. The control measures for credit discipline include:

current control, which is carried out during the semester during lectures and practical classes and is estimated by the sum of points scored (maximum amount - 60 points; minimum amount - 35 points): in lectures the active participation of students in discussions, brainstorming during chat classes is assessed. discussion, online testing; the practical classes assess the quality of the tasks performed, the solution and justification of the case study, the activity of work in small groups and the implementation of projects in small groups;

Modular control is carried out in the form of current control work and colloquium and, taking into account the current control for the relevant content module, aims at integrated assessment of learning outcomes of higher education after studying material from the logically completed part of the discipline - content module. To obtain the required number of points during the semester, students receive a variety of tasks aimed at the formation and development of general and professional competencies. For each practical lesson the student can receive up to 2 points. For perfect performance of tasks during all practical classes the student can receive 24 points. Each lecture has separate tasks in online or offline formats, for the perfect performance of which the student will be awarded 1 point for each such task. For perfect performance of all tasks the student can receive 12 points. Points are also awarded for solving independent tasks and preparing presentations. Such tasks are evaluated during practical classes. During the course the student performs four complex independent tasks for each of which he receives 3 points, a total of 12 points. In general, the course consists of two content modules and, accordingly, has two modular works - a test and a colloquium. For perfect performance of tasks of each modular work the student receives on 6 points. Thus, a maximum of 12 points will be awarded for excellent performance of two modular works.

The final control is conducted in the form of a semester exam, according to the schedule of the educational process. Final control of knowledge and competencies of higher education students in the discipline is carried out on the basis of a semester exam, the task of which is to test the student's understanding of the program material as a whole, logic and relationships between individual sections, ability to creatively use accumulated knowledge, ability to formulate attitudes. to a certain problem of academic discipline, etc. The examination ticket covers the program of the discipline and provides for the determination of the level of knowledge and the degree of mastery of competencies by applicants for higher education. Each exam ticket in the discipline "World Economy and International Economic Relations" contains five tasks of different types of complexity: 2 stereotypical, 2 diagnostic and heuristic, which test the level of mastery of professional competencies. The examination task is performed in writing. The result of the semester exam is evaluated in points (maximum number - 40 points, minimum number of credits - 25 points). The stereotypical task of the examination ticket reveals the level of mastering by the higher education student the knowledge of theoretical substantiation of theories and basic concepts of world economy and international economic relations, definition of forms of international economic relations. The diagnostic task reveals the level of students' mastery of knowledge and skills to summarize the results of calculations and draw competent conclusions to determine indicators of international economic relations. The heuristic task reveals a higher level of students 'mastery of professional competencies in relation to optimizing the development of an international business entity.

The algorithm for solving each problem includes separate stages, which differ in terms of complexity, complexity and importance for solving the problem. Therefore, individual tasks and stages of their solution are evaluated separately from each other as follows: Tasks 1 and 2 (stereotypical) - 4 points, namely: 2 - correct methodological approach to situation analysis, 1 - correct definition of components in this international situation , 1 - registration of the task: substantiation, conclusion. Tasks 3 and 4 (diagnostic) - 6 points, namely: 1 - possession of theoretical knowledge and application of basic

concepts in the context of the problem, 2 - the ability to reveal the essence and justify ways to solve the problem, 2 - apply a creative approach to solving the problem, 1 - sequence and argumentation of the material. Task 5 (heuristic) - 10 points, namely: 2 - choosing a methodically appropriate approach, knowledge of calculation formulas, 3 - arithmetically correct calculation of indicators, 2 - formality of generalization of the problem, 3 - reasonable creative conclusion about the value of the obtained indicators.

Applicants for higher education should be considered certified if the sum of points obtained from the final / semester performance test is equal to or exceeds 60. The minimum possible number of points for current and modular control during the semester - 35 and the minimum possible number of points scored in the exam - 25.

The final grade in the discipline is calculated taking into account the points obtained during the exam and the points obtained during the current control of the accumulative system. The total result in points for the semester is: "60 or more points - credited", "59 or less points - not credited" and is entered in the test "Statement of success" of the discipline.

The final grade is set according to the scale given in the table "Grade scale: national and ECTS".
