INTRODUCTION

Today's business conditions require new abilities from managers – to solve complex specialized tasks and practical problems characterized by complexity and uncertainty of conditions, in the field of management or in the learning process, which involves the application of theories and methods of social, behavioral, managerial sciences.

The course "Introduction to the profession" is a mandatory course for training specialists of the first (bachelor's) study cycle of specialty 073 "Management", study programme "Business Administration".

The purpose of the course "Introduction to the profession" is to provide students with an idea of their chosen profession, a system of knowledge about the essence and content of the study programme "Business Administration".

The tasks of the course "Introduction to the profession" are:

formation students' modern thinking and a complex of special knowledge in the field of management and business administration, a clear idea of the chosen specialty;

familiarization with the features of the future profession, its content and tasks; highlighting the characteristic features, main components, principles and methods of training management specialists;

formation of basic professional management skills;

defining the essence of key concepts and terms used in the management, the appointment of methods, models, systems, mechanisms, technologies used in the management, the foundations of the organization of higher education in the context of the Bologna process;

familiarization with theoretical knowledge and practical skills in the application of organizational and methodical methods of studying different courses;

mastering practical skills in using the library fund, study plans, schedules of the educational process, schedule of classes, performance of self-study, preparation for the final assessment of knowledge, etc. The object of the course is the process of entrepreneurial activity management in order to understand the basics of functioning of enterprises of various forms of ownership in the IT industry.

The object of the course is the process of learning and obtaining learning outcomes under the study programme "Business Administration" at S. Kuznets KHNUE.

The subject of the course is the set of theoretical and practical recommendations on the technology of mastering the chosen specialty by students at S. Kuznets KHNUE, as well as the specifics of the student's educational activities and future professional activity of a specialist in management and business administration.

The learning outcomes and competencies formed by the course are defined in table 1.

2.1. International activities and academic mobility. Adaptation of Ukrainian legislation to EU legislation as an important tool for creating a new legal system and civil society in Ukraine. Development of scientific-technical, economic, social, intellectual, innovative-technological and cultural partnership in the EU.

2.2. Entry of education and science of Ukraine into the European information and educational field. The main tasks and principles of the creation of the European Higher Education Area. Provisions on the procedure for realizing the

right to academic mobility of participants in the educational process at S. Kuznets KHNUE.

Topic 3. Legal and organizational foundations of the organization of higher education in Ukraine

3.1. The essence of the European credit transfer and accumulation system (ECTS) in the system of higher education. Comparative analysis of the ECTS system implementation in various higher education institutions in Ukraine and abroad.

5.1. The essence of academic integrity. Code of academic integrity of the Simon Kuznets Kharkiv National University of Economics. Principles of academic integrity in the university environment. Observance of academic integrity by students. Manifestations of academic dishonesty.

TEACHING METHODS

In the process of teaching the course, in order to acquire certain learning outcomes, to activate the educational process, it is envisaged to use such teaching methods as:

Verbal (lecture-discussion (Topic 1–11); activity in small groups (Topics 1–9). Presentations (Topics 2, 7, 8).

Visual (demonstration (Topic 1–11)).

Practical (practical activities (Topic 1–10), group activities (Topics 4, 8), laboratory studies (Topic 11).

FORMS AND METHODS OF ASSESSMENT

The University uses a 100-point cumulative system for assessing the learning outcomes of students.

Current control is carried out during lectures, practical, laboratory and seminar classes and is aimed at checking the level of readiness of the student to perform a specific job and is evaluated by the amount of points scored:

- for courses with a form of semester control as grading: maximum amount is 100 points; minimum amount required is 60 points.

The final control includes current control and assessment of the student.

Semester control is carried out in the form of grading.

The final grade in the course is determined:

- for disciplines with a form of grading, the final grade is the amount of all points received during the current control.

During the teaching of the course, the following control measures are used:

Current control: presentation (maximum score -20 points (two presentations during the semester, total maximum number of points -40 points)); essay (maximum score -20 points); creative task (maximum score -40 points).

Semester control: Grading.

More detailed information on the assessment system is provided in technological card of the course.
