INTRODUCTION

In today's transformational conditions, an important and relevant direction of further activity in the field of European integration is Ukraine's active transition to modern European social standards, which is directly related to the reform of the existing social policy and economy. The study of the problems of social economy and politics acquires special importance, since they are closely related to the social protection of the population, and also determine the main directions of social service in society. In modern crisis conditions, the relevance of studying issues of social economy and politics becomes more important and obvious, which is connected with the complication of social interaction processes both at the state level and at the enterprise level.

The main goal of the study of issues of social economy and politics is to balance the relationship between man and society, man and the state; a system of specific measures aimed at the livelihood of the population. At the center of the realization of the goals of the social economy is always a person, his well-being, social protection, life support, social security.

The educational discipline "Social Economy and Politics" provides an opportunity for students of the third (educational and scientific) degree of higher education to master the basics of knowledge of connections and dependencies of economic relations with political, socio-cultural, moral, ethical, psychological and other aspects of human life; determining the priority of a person as an individual who is formed in a complex, dynamic, contradictory environment (humanization of economic relations).

The goal of the educational discipline: formation of a system of theoretical knowledge and applied skills and competences regarding the use of methodological apparatus and tools of social policy and mastering the skills of making optimal management decisions in the conditions of market relations.

To achieve the goal, the following main tasks are set:

elucidation of the mechanism of action of economic laws and their use by people in the process of economic activity;

determination of the general features of the economic behavior of the main economic subjects and directions of their evolution; their functions in the functioning and development of the economic system;

promoting the formation of a humanistically oriented professional outlook;

understanding the main stages of the development of social policy as a science, its types and modern trends;

vision of social policy as a complete self-regulating system;

mastering the main categories and concepts of social economy and politics;

forming an understanding of the features of the analysis of the main social processes;

familiarization with methods, regulatory documents defining and regulating social policy measures.

The object of the academic discipline is the processes that take place in the sphere of social economy and politics.

The subject of the academic discipline is the system of knowledge and methods for solving issues in the field of social economy and politics.

TEACHING METHODS

In the process of teaching an educational course, in order to acquire certain learning outcomes, to activate the educational process, it is envisaged to use such learning methods as:

Verbal (lecture (Topic 1, 2, 4, 7, 12), problem lecture (Topic 3, 5), lecturedialogue (Topic 6)).

In person (demonstration (Topic 1-7))12

Practical (practical work (Topic 1 - 7), seminar (Topic 6), business games (Topic 4).

FORMS AND METHODS OF ASSESSMENT

The university uses a 100-point accumulative system for evaluating the learning outcomes of students of higher education.

Current control is carried out during lecture, practical and seminar classes and is aimed at checking the level of readiness of a higher education applicant to perform a specific job and is evaluated by the sum of points scored:

- for courses with a form of semester control as grading: maximum amount is 100 points; minimum amount required is 60 points.

The final control includes current control and an exam.

Semester control is carried out in the form of a semester exam or grading. *The final grade in the course* is determined:

- for disciplines with a form of exam, the final grade is the amount of all points received during the current control and the exam grade. During the teaching of the course, the following control measures are used:

Current control: Individual educational and research tasks (10 points), written control work (20 points), colloquium (15 points), essay (15 points).

Semester control: Grading including Exam (40 points).

More detailed information on the assessment system is provided in technological card of the course.

An example of an exam card and assessment criteria.

EXAM TICKET 1

Theoretical block

1. Problems of employment and labor activity of the population. Migration processes as a challenge of today.

2. What is the role of the Ministry of Social Policy of Ukraine in the system of state executive power? Describe its structure.

Practical block

Calculate the coefficient of economic activity of the population; population employment rate; unemployment rate based on the following data:

average annual population -9,800 thousand people;

the number of economically active population - 5,600 thousand people;

the number of employed persons is 4,900,000.

Determine how the number of unemployed per 1,000 employed in the region has changed (in absolute and relative units), if in the previous year it was 150 people.

Evaluation criteria.

The examination ticket for the academic discipline "Social Economy and Politics" includes a theoretical and practical block: 2 theoretical questions and 1 task of practical orientation.

Each of the tasks is evaluated with a certain number of points, according to their

level of difficulty. The total number of points is 40 in accordance with the qualification requirements for doctors of philosophy, specialty 051 "Economics" 1 year of study.

Theoretical component.

The maximum number of points is 20. A correct answer to a theoretical question is valued at 10 points.

Practical component.

The maximum assessment of the task is 20 points, of which:

10 – the correct methodical approach, knowledge of the formula for calculation;

5 – correct arithmetic calculation of the indicator;

2 – execution of the task solution: solution, units of measurement, answer;

3 – availability of justified conclusions about the dynamics of indicators.
