The disadvantages of static content include: if you need to change something on the "server side" of the website, you have to be at your computer in a development environment to make the changes; you could create your own CMS-based software with static HTML, and then use your content management systems to edit the site's content from anywhere. However, this would require a significant amount of time and effort, not to mention significant technical coding knowledge.

Unlike the previous one, dynamic content is content that is stored in a database. It is displayed directly from the database to the user's browser page. A CMS is often used to work with dynamic content.

The advantages of dynamic content with CMS include the following: you can change content frequently; installation is very quick and easy; no special technical knowledge in coding is required: all the tools for adding text, images or videos, as well as for creating new pages or subordinates are provided within the platform itself; most platforms have a built-in security system; various templates are available

that you can modify according to your needs; most templates are already responsive; it is easy to add third-party plugins to the system, such as banner sliders, image galleries, SEO tools and e-commerce systems; you can manage your content from any computer, anywhere there is an Internet connection; no FTP software is required to upload content to the Internet; good connection with search networks; blogs are already built in and ready to go.

The disadvantages of dynamic content include: CMS requires more memory, CPU power, and software maintenance than its HTML competitors; small changes to server settings can cause the entire site to crash; some templates are poorly coded; creating a huge and complex website with a content management system is not the best idea: for example, a site like amazon.com has a rather complex, large design that would be impossible to create using CMS-based platforms. It is better to create it from scratch using your own HTML and other programming languages.

One of the open source content management systems that makes it easy to create and manage a website is WordPress, which is one of the most popular CMSs in the world. People use WordPress every day to maintain their online presence.

One of the advantages of WordPress is that it is free to use: there are no installation fees or annual costs, except for hosting.

This software is available at zero cost because it is run by volunteers who participate in an open source project.

Open source software is unlike other tangible products because no company or individual owns WordPress. For this reason, its support, maintenance, and development depend entirely on volunteers.

Also, the WordPress editor Gutenberg - a plugin that is already built into the latest versions of WordPress, allows you to visually and without using code to change the content of pages and posts.
